All AHRA Licenses are considered "Sportsman/Hobbyist Licenses", as there are NO professional drivers or classes within the AHRA, and are based upon ET and Speed of the cars. Licensing is a means to verify Driver Competency, Physical Capability, and Skill Levels inherent with ET and Speed of the vessel being used for racing. Upon Completion, Licenses are used as a way to identify a driver has displayed the minimum standards of Cockpit Familiarity, Safety Equipment Use and Vessel Operating Abilities.

AHRA License Lengths and Options: All licenses cannot exceed the membership length but can be purchased based upon membership lengths out to a 5 year maximum and will expire upon the expiration of the membership date for the time frame selected (for example – a member can have a 1 year licensing agreement and a 3 year membership or a 3 year membership commitment to obtain a 3 year license, a 5 year license and 1 year membership **is not allowed**. Both membership and license expire upon the membership expiration date) or unless any one of the following instances occurs:

- 1: An accident that would place driver competency in question (as deemed by an AHRA/Track Official). This would initiate a temporary suspension of driving privileges until a re-evaluation of driver competency can be demonstrated visually to the identifying AHRA/Track Official. Member Initial: _____
- 2: A medical situation that would place driver's physical abilities in question (as deemed by an AHRA/Track Official). This would initiate a temporary suspension of driving privileges until a re-evaluation of driver physical abilities can be demonstrated visually to the identifying AHRA/Track Official. Member Initial: _____
- 3: A driver that is deemed impaired by drugs or alcohol during operation of a racing vehicle, regardless of time or place, will invoke an indefinite suspension of an AHRA Racers License. Membership will remain intact, however licensing privileges will be revoked indefinitely and any remaining time or monetary values of the license will be forfeit to the AHRA. Member Initial: _____
